BESTWA, Inc conducts a child feeding program for malnourished children in Liberia. Children are given a daily hot, nutritious meal. In 2015, BESTWA, Inc. fed 917 children each day. The organization provides University Scholarships to 8 individuals, including 2 graduates with advanced degrees. 400 children from the feeding program were placed into elementary schools, many for the first time. The children also receive emergency medical care. The organization also imported and distributed three 40 foot containers of food and an air shipment of essential medical supplies to indigent individuals. BESTWA, Inc. continues work on building a Birthing Clinic and School of Midwifery.
