BESTWA, Inc conducts a child feeding program for malnourished children in Liberia. Children are given a daily hot, nutritious meal. In 2014, a third feeding site was opened enabling BESTWA, Inc to feed 917 children each day. 538 children from the feeding program were placed into elementary schools, many for the first time. The children also receive emergency medical care. The organization also imported and distributed four 40 foot containers of food and an air shipment of essential medical supplies to indigent individuals during the height of the Ebola Crisis. BESTWA, Inc continues work on building a Birthing Clinic and School of Midwifery.
