## **REGISTERING ONLINE**

- If you register by **June 1**, the cost is **\$250**. If you register more than one child from your family, each additional sibling cost is \$200.
- If you register **June 2** or after, the cost is **\$280**. Each additional sibling is still only \$200.
- Register your first child at full price, then use the promo code: **SIBLING** to register additional siblings.
- To reserve your spot(s), you must make a minimum, non-refundable downpayment of **\$50** during registration. You have the option to either hold your child(ren)'s reservation(s) by making the downpayment **OR** paying in full; you will be able to choose your selection on the check-out page.
- **Payment in full is due no later than June 28, 2013.**

## Cost & Registration:

**Deposit to hold your spot: \$50**

**Camp Cost: \$250**

Costs covers all transportation, lodging, meals (except one lunch on our way back home) and fun. *All campers should bring at least \$8 in cash for one meal on the road on our way back home on July 3rd.*

You may register online, pay your camp cost, and download all camp forms online at [Bethelbrentwood.org](http://Bethelbrentwood.org). If you do not have an online account on Bethel's website, you will need to open one to register your student.

***Please note: A complete registration is considered to be both your trip cost paid AND all your forms completed and turned in at RUSH.***

Students may also bring money to purchase snacks and other items. Yum yum.

### Scholarships:

- We do our best to help students be able to participate in all trips regardless of financial situation. Should you need a partial scholarship for this trip, you may fill out the *Scholarship Request Form* included in this packet.

### Medications

- All medications must be turned in to our nurse before departure in **ORIGINAL CONTAINERS**. Do not put student medications in plastic bags or other foreign containers or they will not be accepted. Adult sponsors will dispense medications for students under 18 at appropriate times.

### Leader Coverage:

- We will be maintaining the proper leader (includes young adult and parent leaders) to student ratio based upon to ensure safety and vigilance during our camp experience.

## Important Media Restrictions:

- Student cell phones will be collected upon arrival at Bethel on Sunday morning by their group leader. They will not have access to them unless it is for specific reasons to call home. Should you need to reach your student you can call any of the above numbers to get them on the phone. We collect phones to help students “unplug” from their digital, texting, facebooking worlds so they can get the most out of their time together. Phones will be handed back out when we return home.
- **No** MP3 players, ipods, etc... will be allowed on the trip. They will be confiscated if found. Our goal is to put students in an environment where they don't check out but relate to one another and make new friends. During bus time students will be encouraged to talk, sleep, read, or watch movies together on the bus TV's.

**WAIVER AND RELEASE BY PARENT OF MINOR CHILD**

I, \_\_\_\_\_, on behalf of \_\_\_\_\_ (hereinafter referred to as "CHILD") HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge BETHEL WORLD OUTRACH CHURCH (hereafter, "Bethel") a non profit 501(c) (3), and its agents, employees, officers, directors, affiliates, successors and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I or CHILD ever had or may have, arising from or in any way related to CHILD'S participation in any of the events or activities conducted by, on the premises of, or for the benefit of, Bethel provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct.

I understand that the activities and functions that said CHILD will participate in may be inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. On behalf of myself, CHILD, my heirs, assigns and next of kin, I and said CHILD waive all claims for damages, injuries and death sustained to me or my property, that I or said CHILD may have against the aforementioned released party to such activity.

CHILD has the necessary and requisite skills to participate in the requested activities and CHILD'S only limitations or activities from which said CHILD is prohibited are noted below. The nature of the activities has been fully disclosed and any flyer, advertisement, or brochure relating to the participating activities is expressly made a part of this WAIVER AND RELEASE.

The provisions of this WAIVER AND RELEASE may be waived, altered, amended or repealed, in whole or in part, only upon the prior written consent of all parties.

The provision of this WAIVER AND RELEASE will continue in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of, Bethel whether by agreement, by operation of law, or otherwise for the remainder of this calendar year.
