Bidding Documents require a deposit of **\$100.00** for each set of documents. Deposit for the first set is fully refundable to all bonafide prime bidders who submit a bid upon return of the documents, in good condition, no later than ten (10) days after receipt of bids. The deposit of all other sets of documents will be refunded fifty percent (50%) upon return of documents as stated above. General Contractors not submitting a bid on the project will be refunded fifty percent (50%) of plan deposit upon return of bid documents within ten (10) days after receipt of bids. Bidding Documents will be available at the address above on April 11, 2014.

Contractors may elect to submit bids electronically via the internet. Electronic bids for the Bossier Parish School Board are available for submission at www.bidexpress.com. Contractors that wish to submit electronic bids online will be charged a fee by BidExpress. In addition, contractors shall be required to obtain a digital signature certificate prior to submitting bids online. The bid security required by this solicitation may also be submitted online. Bid information for electronic bid submittal and bid documents for this project are available at www.bidexpress.com.

The Classic Reprographics and BidExpress will each maintain a separate list of plan holders.

Work on this Project includes all work as indicated in the Construction Documents (Bid Documents), which includes Drawings, Project Manual and Addenda (if any).

NOTE: BIDS SHALL ONLY BE ACCEPTED FROM CONTRACTORS WHO ARE LICENSED UNDER LOUISIANA CONTRACTORS LICENSING LAW FOR THE MAJOR CLASSIFICATION OF GENERAL CONSTRUCTION. No bid may be withdrawn for a period of forty-five (45) days after receipt of bids, except under the provisions of LA. R.S. 38:2214.

All Bids must be accompanied by Bid security equal to five percent (5%) of the sum of the base Bid and all alternates and must be in the form of a certified check, cashier's check or Bid Bond written in

1 conformance with state law.

3 The successful Bidder shall be required to furnish Maintenance, Performance and Payment Bonds on the
4 forms provided by the School Board and written in accordance with state law.

6 The Owner reserves the right to reject any and all bids. Bids which deviate from the Construction
7 Documents will not be considered.

10 School Library located at 2801 Airline Drive, Bossier City, La. 71111. Attendance at the Pre-Bid
11 Conference by an Officer or Estimator directly involved with this Project is **MANDATORY** and is a
12 Pre-Condition for bidder eligibility. Sign-in for the Conference will be between 1:30pm and 2:00pm.
13 The Conference will begin promptly at 2:00 PM, April 28, 2014. No one will be allowed to sign in after
14 that time.
