## SYNOPSIS

The previous editions of the SIA forms of contract were widely used in private sector projects in Singapore since 1980. In end 2016, the SIA released its suite of new contracts namely the SIA Building Contract 2016 ( With and Without Quantities), the SIA Building Contract 2016 for Design and Build and the International SIA Building Contract 2016 ( International). In this seminar, Mr Christopher Chuah, a senior accredited specialist in Building & Construction Law, will examine the key differences between the new forms and the old editions and consider the legal implications and ramifications arising from these changes. This seminar will benefit developers, consultants and contractors who are using the new forms in their current or future projects.
