4. Be responsible for my own behavior and participate fully in all scheduled activities of Vacation Bible School, abiding by the rules and instructions of Staff.
5. Help ensure safety for myself and others by not bringing weapons (*including pocket knives*), explosives, or fireworks of any kind.
6. Maintain a positive attitude and be thoughtful and friendly to others.
7. Follow the leader requirements and dress code as listed in the Handbook and all other rules stated by the FaithKids Vacation Bible School Directors.
8. Not take any pictures of the children.
9. Keep cell phone and electronic devices in my pockets at all times.
10. I will arrive on time each day. If I am unable to come or will be late, I will contact my Ministry Leader immediately.
11. If I have any special needs or serious health issues I will notify my Ministry Leader prior to my volunteer date.
