FROM THE PASTOR ...

Many thanks to you for allowing your pastor to have two weeks vacation in both the spring and fall. This allows for time to rest, to air out my mind, and to recharge my spiritual batteries. One of the ways I try to do this is by reading new books which I have discovered.

One of the books which has been especially helpful to me is What Jesus Wished People Knew about God. It was published in 2017 and was authored by Jurgen O. Schulz.

I shared a lot of it in my sermon on the last Sunday in February.

The entire book is a fresh and thoughtful treatment of the parable of the prodigal son.

I plan to continue to preach a series of sermons on this memorable parable using the book by Schulz as a major resource. Probably nothing we believe has more impact on how we live out our lives than what we believe about God. And this series will provide a unique opportunity to reflect more carefully on how we think about God in our minds and feel about Him in our hearts.

The first sermon in the series focused on Chapter I in Schulz's book, "The God Who Looks Like Jesus."

A major emphasis of the book is that God is like Jesus. If we want to develop a good mental picture of who God is, we need to look at the face of Jesus Christ. Jesus came to show us who God really is. And no portion of the Bible does this better than the parable of the prodigal son.

I suggested in my first sermon that a more accurate title for the parable would be "The Parable of the Waiting Father." Because, as I and Schulz see it, the parable focuses primarily on the father.

In my first sermon, I pointed out how the first two verses of Luke 15 show us something very important about God. And that is: God welcomes sinners!

The parable is told by Jesus against the backdrop of the religious leaders criticizing Jesus for welcoming and eating with sinners. Jesus mixed, mingled, and ate with sinners. Now, if God is like Jesus, then that means that God loves sinners, too!

Unlike the religious leaders of His day, the people known as "sinners" (tax collectors, prostitutes, etc.) were attracted to Jesus. Jesus had the ability to love sinners without approving of their sins. This is sometimes difficult for us to do.

I closed my sermon with a question and a confession. It went something like this: "What about us? If God is like Jesus and he welcomed and ate with sinners, what are the implications for those of us who say we are followers of Christ today? Do we befriend and eat with sinners? Are sinners attracted to us like they were to Jesus? I must confess that I do not welcome and eat with sinners like Jesus did. I fall short and miss the mark of imitating Jesus in this way. But there is something about his example that pushes me out of my comfort zone so that I might move in the direction of welcoming sinners--and eating with them--like Jesus. I hope that all of us are challenged by our Savior's example!"

Please pray for me as I continue this series. I trust that it will help all of us to get a fuller and more accurate picture of the God of the Bible, the God who is like Jesus. And, may it help us to move closer to becoming like Christ in the way we live out our lives.






