

FROM THE PASTOR ...

"Let Not Your Heart Be Troubled"

These words of our Savior from John 14:1 are one among the most familiar and beloved text of Scripture. They uniquely stand here to comfort, assure, and remind and believers across the world even during these modern troublesome times of the pandemic spread and deaths caused by the Coronavirus that our current circumstances have not caught God by surprise.

Some may retort, that's easy enough to say, and I would agree. Surely the things of God are easy enough to repeat back to God that even a child can recite the verse from memory. The good thing is that this reminder from the lips of our Savior come with assistance to not only repeat the words, but to also apply them to our hearts and minds to the end that your and my hearts are not troubled by the events of life and the world around us. Yet, there are several things required of you and me if non-troubled hearts are to be our realities.

First, are Jesus very next words; "you believe in God, believe also in me." Most every human being alive believes in God. Yet in this verse, lesus points to Himself as the very object of the same religious trust as believers have in God, reminding us that faith in Him is what is required if we ever expect to find the peace of an untroubled heart, for lesus made flesh is the visible image of God who is unseen spirit. Jesus further reminded Philip of this very truth in verses 9 and 10; "Have I been so long a time with you, and yet have you not known me, Philip (notice how Jesus makes His remark personal)? He who has seen me has seen the Father." Should we not therefore place our complete confident trust for our heart's peace in the One who died for us, who was able to raise both Himself and every believer from the grave? This is at the heart of the Christian faith, peace with God in our Lord Jesus Christ brings about peace throughout the course of our lives, through uncertain times, as well as in times of sufferings.

Secondly, the outcome of this peace with God is far beyond the tangible realities of this world's comforts. Jesus repeats His exhortation of John 14:1 in the reality of our faith's application of His life to our souls; "Peace I leave with you, my peace I give unto you: not as the world gives, give I unto you. Let not your heart be troubled, neither let it be afraid," John 14:27. His peace for our soul's heavenly home also results to apply peace in our every day physical life (see also Matthew 6:25-34).

Finally, Henry Francis Lyte, the author of the beautiful and comforting hymn, "Abide with Me," also wrote a lesser known hymn about the believer's peace in his hymn, written in 1833, "The Pilgrim Hymn." Listen to the lines of his 4th and 5th verses; "Afflictions may damp me, they cannot destroy. One glimpse of His love turns them

all into joy; The bitterest tears, if He smile but on them, Like dew in the sunshine, grow diamond and gem. Let doubt then, and danger, my progress oppose; They only make Heaven more sweet at the close. Come joy, or come sorrow, whate'er may befall, And hour with my God will make up for it all."

As Christ said, "you believe in God, believe also in me. Speak and teach His same peace to your own heart and mind so that your heart may not be troubled, knowing that God also uses the calamities of this life to accomplish His divine purposes. There is nothing faith in Christ has not done, nor cannot do (see also Hebrews II) to supply the still quiet voice to your and my heart to accomplish what we seek in Him, peace, be still...for Jesus has gone to Heaven to prepare that eternal mansion, "if it were not so, I would have told you," John 14:2, 3.


