

FAQs

How do I get started?

Request an application from the finance office or download it from our web site at www.gemstate.org and click on admissions. Click financial aid, then on the PDF link for the Early Enrollment Incentive Program. Each student is eligible for only one EEIP enrollment.

What is the “monthly tuition rate”?

The monthly tuition rate is one-tenth (10%) of the annual tuition, as established by the GSAA Operating Board, during the year your student enrolls in 9th grade. The annual tuition is the yearly cost for day students.

What if I move or decide not to attend GSA? Do I get my money refunded?

Yes, you will receive a full refund for the amount you paid toward registration.

What if I miss a payment or my total payments do not equal the initial payment due?

We match the amount you’ve paid “up to” the initial payment. For example, if the initial payment is \$1000 and you only paid in \$450, then you would receive \$225 if you meet the eligibility requirements for the 8th grade. You would receive \$450 if you meet the eligibility requirements for the 7th grade. You would receive \$675 if you meet the eligibility requirements for 5th or 6th grades. To receive the maximum incentive, we need to receive the full matching payment amount by June 30 following 8th grade graduation.

Payments made after June 30 following 8th grade graduation are not eligible for matching funds.

If I miss the deadline, can I still participate in the incentive program?

Sorry. You have until October 1 of your child’s 8th grade year to sign up. The purpose of this program is to inspire interest in attending GSAA. In order for us to offer these incentives, it requires us to receive your payments on a timely basis.

How will I know what I have paid over time?

Each participant in the program will receive a quarterly statement showing the amounts paid.

What is GSAA “Finder’s Cash” Program?

Each student enrolled in the Early Enrollment Incentive Program is eligible for cash awards. If you enrolled in the EEIP and are responsible for another student enrolling in this program, he or she upon verification of such student shall receive \$20 in cash.

What is the verification process and when do I get paid the “Finder’s Cash”?

At the bottom of the application, space is provided for the student name, address and phone number. When that student applies for EEIP, they will be asked to write down the name of the student who invited them to enroll. If the name matches, it is at this time payment can be made.

PURPOSE AND SCOPE

Enrolling early will result in GSAA matching funds. We will accept multiple or one-time payments.

INCENTIVES FOR 8th GRADERS – 50% match

To qualify for this incentive program, you must submit an application with the EEIP enrollment fee of \$100 on or before January 31 of the 8th grade year. Matching funds are based on payments received by June 30 following your student's 8th grade graduation. GSAA will match 50% of your total payments that do not exceed the monthly tuition rate the year that your student enrolls in 9th grade.

This incentive is limited to students enrolled in the early enrollment program and cannot be combined with any other grade incentive.



INCENTIVES FOR 7th GRADERS – 100% match

To qualify for this incentive program, you must submit an application with the EEIP enrollment fee of \$100 on or before January 31 of the 7th grade year. Matching funds are based on payments received by June 30 following your student's 8th grade graduation. GSAA will match 100% of your total payments that do not exceed the monthly tuition rate the year that your student enrolls in 9th grade.

This incentive is limited to students enrolled in the early enrollment program and cannot be combined with any other grade incentive



INCENTIVES FOR 5th or 6th GRADERS – 150% match

To qualify for this incentive program, you must submit an application with the EEIP enrollment fee of \$100 on or before January 31 of the 5th or 6th grade year. Matching funds are based on payments received by June 30 following your student's 8th grade graduation. GSAA will match 150% of your total payments that do not exceed the monthly tuition rate the year that your student enrolls in 9th grade.

This incentive is limited to students enrolled in the early enrollment program and cannot be combined with any other grade incentive
