## **2012 Annual Report**

## Dr. Doug Talley Executive State Minister

When Peyton Manning was the quarterback of the Colts, I wanted a touchdown out of every possession. (Often times that was needed to win as the Colts offense wasn't usually a steel curtain during Peyton's reign.) Now that Peyton has absconded to the Broncos and the Colts have a rookie quarterback, I'm having to redefine my expectations. If the Colts move the ball down the field towards the end zone (in other words – don't go three and out), then I feel like it was a productive possession. Now the operative word is "progress," rather than "touchdown." Don't get me wrong. I still want touchdowns but I realize that progress is often the accomplishment I need to celebrate.

My analogy translates into ministry, both at the local congregational and state levels. While we'd like to score a touchdown every day or week, sometimes we need to remember to celebrate progress. While progress doesn't necessarily translate into a win on the football scoreboard, I think it does in ministry.

This year has been another year of progress for Indiana Ministries. One of my overarching goals is that our congregations in Indiana own a culture of church health and growth. I'm seeing indications that this culture is developing. I know of an increasing number of congregations that are working on becoming healthier in how they relate to each other, respond to changes, handle issues, and pursue their mission. Do we still have work to do? Absolutely. Are we moving the ball down the field? Absolutely.

Each previous year (since my arrival in late 2008) in my annual report, I've noted changes in the Indiana Ministries staff. I have no new changes to report this year! I'm elated with how the present staff works together and jointly owns the mission of Indiana Ministries. We have an incredibly gifted staff who aren't just cheerleaders. Each one is willing to lay it on the line to move the ball down the field. Jeff, Jenene, Cassie, Carl and Cindy – thank you for your incredible commitment to Indiana Ministries and the pastors in our state. You are enabling Indiana Ministries to make a difference!

Here are some of Indiana Ministries' accomplishments and involvements during the past year:

- •
- Supported David Ravell and Journey Church, our church planting partner in Australia.
- Hosted one financial Best Practices conference with two more regional conferences scheduled for this fall
- Provided financial scholarships for pastors who qualify for the Lilly Endowment (Financial Freedom Fund). Since the grant was first awarded in late 2008, thirty-five qualified Indiana Pastors (many benefitting from more than one area) have received . . .
  - \$52,469 in student loan payments,
  - \$23,234 in pension payments,
  - \$50,600 in healthcare payments.
- Been awarded a supplemental Lilly Grant for \$75,000 that allows us to continue helping pastors who qualify for scholarships.
- Have 30 pastors or associate pastors involved in SHAPE Sustaining Health and Pastoral Excellence.
- Sponsored a pastor's wives retreat.
- Completed a financial review audit for years 2010 and 2011.

The Board of Directors of Indiana Ministries is another team I'd like to express appreciation to. They believe in our mission of growing healthy missional churches and are deeply committed to Indiana Ministries. They bring wisdom, insight, support and accountability that enables me to do my job at a higher level. They make me feel like I am doing the most important job in the world and cheer me on in a way that inspires me to do my best. A special thanks to Dan Chitwood, Travis Inman, Jeff Boyer, John Crump, Shelly Clasen, Craig Knisley, David Markle, Troy Scott and Kathi Sellers.

I also want to express gratitude to the ministers and laypersons who serve on the various teams of Indiana Ministries: Department of Youth Ministry, Department of Ministry Services, Consultation & Coaching Team, Consultation Prayer Team, and Ordination and Licensing Teams 1 & 2. These team members invest significant time and energy serving churches and pastors. Thank you for your love for the church, the mission, and the people!

Here are a few goals for 2013 that align with Vision 2015:

- Continue supporting the church plant known as The Southeast Project (Ryan Carrell, Lead Pastor).
- Take next steps in planting a church in Northwest Indiana.
- Invite approximately 10 Indiana pastors to be coached by our own Ministry Advantage coaches.
- Complete six church consultations.
- Coach and resource covenant churches to accomplish their mission.
- Fully implement the new online credentialing process.
- Host 2-3 leadership training events for pastors.
- Continue to fund scholarships for the Financial Freedom Fund.
- Sponsor the SHAPE ministry for pastors and associates.

Your financial contributions to Indiana Ministries makes what we do possible. Since the inception of state ministries, it has been recommended that local congregations provide financial support at 3-5% of their budget income. While that level of support is invaluable for what we do, all levels of support are welcome and appreciated. I want to express gratitude to several churches that have increased their support for Indiana Ministries this past year. Thus far in 2012, ninety (65%) of the Church of God congregations have supported IM. Progress is being made as that is more than last year at this time!

I continue to be excited about what God is doing in our churches in Indiana. The Holy Spirit is blowing across our state and challenging us in new ways. God has placed a vision in our hearts, and it is such a privilege to be working with you to accomplish it. May God resource and bless us as we serve Him and pursue His vision.

### **Department of Ministry Services Report**

The Department of Ministry Services (DMS) carries the primary responsibility for the credentialing of vocational ministers, which includes overseeing ordination and licensing process. In crisis situations, the DMS may provide leadership to initiate investigative teams, peer support, and reconciliation efforts. When necessary, the DMS has the authority to review—and determine the ultimate status—of a pastor's credentials. Also, the department is responsible for developing resources, policies, and procedures for pastors and local congregations. Over the past year, we have engaged in activities covering all of the above primary responsibilities.

Six ratified members compose the DMS: James Lewis (Chair); Jeff Veatch (Vice Chair); James Cook (Executive Committee member); Mary Ann Randolph; Ann Smith; and Jerry Yoder. Two additional members represent their respective Ordination and Licensing Committees: Chris Gammello (Ordination and Licensing I); and Terry Canfield (Ordination and Licensing II). Kay Shively serves as the Indiana Ministries caseworker. Kay Shively will be leaving the DMS in October, and Dr. Michael Linville, the newest member of our Committee, will be our new caseworker. Jenene Lighty from Indiana Ministries serves as Secretary to the DMS. As needed, Doug Talley serves as consultant and liaison [as appropriate] from Indiana Ministries.

Annually, we meet to approve or disapprove Indiana ministers, congregations, missionaries and freestanding organizations for listing in the Yearbook of the Church of God. We completed this task on August 23, 2012.

In addition, we sense that there is widespread support for the Code of Ethics. Yet, we are committed to monitoring how it is functioning and informing our ministers as to its specifics. The DMS is still looking forward to the preparation of an ethics document for congregations. James Lewis and Doug Talley in the coming year will intensify efforts at drafting such a document for review and implementation.

Each year, the DMS celebrates with those whose call to ministry is being recognized. Five leaders are being ordained in this years Ordination Service. You will find their names in the reports of the Ordination and Licensing Committees. To all of you who mentor, guide, and encourage ordination candidates through their ordination process, God bless you for your service.

The DMS exists to serve the churches and pastors of Indiana Ministries, and our missionaries whose credentials we also hold. Please send us your questions, concerns, or advice. We welcome them. Please do not hesitate to call or contact in any way the DMS members whose names you find above. You can find our current contact information in the Yearbook of the Church of God. Meanwhile, thank you for your partnership in our common labor of love in support of Indiana pastors and churches.

### **Camp Challenge Report**

God continues to bless the children that attend our summer camps. We got reports from several parents that said their children had a great time, but even more important had grown spiritually. Our directors along with the counselor staff this summer did an exceptional job creating an atmosphere where the Holy Spirit could impact the lives of the campers.

The Board of Directors decided to approach this camping season a little differently than in the past. They used a common theme for the entire summer "Epic Quest" based on Joshua 1:9. The directors were then allowed to develop their curriculum around the theme. Additionally, decorations were put up for the summer that included castle towers near the admin building and a statue of a knight named "Sir Standsalot". He would appear at different places throughout the camp week.

Due to some generous donations from individuals and Church at the Crossing, we were able to make some significant improvements to Amity Hall and add outdoor games for octoball, tetherball, and four square. The work in Amity included carpet, new French doors, air conditioning, and then new lights and paint in the craft room downstairs. The result was that most of the services over the summer were held in Amity instead of the shelter house or the retreat center. The games, especially octoball, were huge hits with the kids.

Many Christian camps around the country are closing due to a lack of funding. Camp Challenge has not reached that point yet. However, we would like for the congregations of southern Indiana to prayerfully consider increasing their regular giving to the camp so that we can not only maintain the ministry but continue to improve it. There are very few experiences that a child can have that will impact them spiritually as much as a week of camp!


