STATEMENT OF FAITH: JOHN BARKETT

I believe in a triune God who can be understood in the persons of Father, Son, and Holy Spirit. All persons of this triune God are one in their substance and essence, yet different in their revealing of themselves to human beings in the past, present, and future of time. The full understanding of the Trinity is a mystery to our limited human understanding.

God the Father is the spirit who is the ongoing creator of this world and all that is in it. The world is not God. God loves creation which was, is, and will be created for all.

God the Son is Jesus, the Redeeming Christ and Messiah, who came to earth to be the final atonement for all of humanity's sins. Jesus, was raised from the dead to show God's power over sin and death. He conquered death, the final frontier, for our salvation. After his resurrection Jesus ascended into heaven. Jesus was born of a Virgin, caused by God the Father through the Sustaining Holy Spirit. Jesus is both human and God, two perfect natures in one being. Being human and God, Jesus understands our struggles, yet being God, he has the power and authority to heal that which is not complete and whole in our lives. Jesus will return in glory and triumph.

God the Holy Spirit is the teacher, wisdom, challenger, comforter, and power of God that descends from the Father to aid our struggle to serve God. The Holy Spirit draws all humanity to God.

Sin is the rebellion against God which prevents our knowing God and prevents our full potential and joy in the life of God's Kingdom. Sin is committed knowingly and unknowingly, voluntarily and involuntarily, out of our desire to love ourselves before we love God.

Repentance is part of the act of salvation where one realizes their sinful nature and their finiteness. One turns to God to overcome sin through faith in the atoning work of Jesus Christ.

Salvation is when one comes to the knowledge and internalization of the forgiveness, love, and oneness of the relationship between that individual and God. In doing so one recognizes the Lordship of Jesus Christ. Salvation is an act affecting the individual with consequences to the whole community of faith. Christians are called to live their salvation in ministry to all. Salvation in an understanding from the Old Testament can also be understood as deliverance from evil.

Sacraments, the Lord's Supper and Baptism, are signs, seals, and symbols of our redemption in Jesus Christ and are instituted by Jesus Christ. They are given to the church to remind us of our salvation, establish community, and fellowship. In the sacraments, Christians celebrate the redemptive and salvific works of God and their unity with other Christians. Christ is present in the sacraments. Belief and faith are needed before receiving the sacraments, otherwise there is no spiritual value to those participating and sharing in them.

The Scriptures (Old and New Testament) are God's inspired word telling us of God's work in history. Scripture convicts, teaches, inspires, and corrects us in our walk with God.

The Church is all the believers in the Triune God who believe in Jesus Christ as the instrument of the church's salvation. Jesus Christ is the Lord and Savior of the Church. Belief and faith in Jesus Christ as God's agent of salvation is the basis of membership in the Church. God calls the Church to minister to the world and spread the Good News of Jesus Christ in word and in acts of healing, mercy and justice. The Church is the presence of God in the world and acts as God's instrument to make the Kingdom of God a present and viable reality.

Stewardship is the responsibility to use all Creation so that its use brings honor and glory to God. It is sin to destroy and misuse the Creation that God has given humanity.

Appendix D

Report from the 223rd General Assembly (PCUSA)
Mary M Dusenbury, Elder Commissioner

Following are a few facts and highlights that I'd like to share from the 223rd General Assembly. There is much more information in *Presbyterians Today, Outlook,* and on the PCUSA website. The latter includes email versions of the newspapers published each morning during GA.

I was also a commissioner to the 1992 GA in Denver. This one was much more diverse in composition, especially among staff and elected officials, adding depth, breadth of experience and insight to our deliberations. We were also enriched by the participation of a variety of invited advisory delegates - Young Adult Delegates (YAD), theological students, missionaries, and 14 people invited from various communions in mission partnership with PC(USA) from other countries. Also presbytery, synod and OGA staff as well as 625 registered observers.

Mark Miller and I were the commissioners from PSK, two among the 538 commissioners from our 170 presbyteries. We did not have a YAD this year. The YADs contributed a great deal and learned even more. I hope we will make a real effort to send an appropriate young adult to the 224th GA.

Reorganization of OGA: For several years the Office of the General Assembly through **the Way Forward Committee** has been working on a plan to reorganize the structure of the OGA for better efficiency and reduced expenses. We approved the reorganization.

Fiscal Responsibility: I was impressed by the close attention paid to costs. Before every decision that required funding to implement, a designated committee was given the data and reported back to the committee or assembly with a detailed break-down of projected expenses before final deliberation and vote.

Retired Stated Clerk **Gradye Parsons** spent a year travelling around the US visiting churches and collating his findings in *Our Connectional Church: The Hopeful Future of the PC(USA)*. Two other featured books of the **Presbyterian Publishing Corp** were our new hymnal, **Glory to God**, and the newly revised *Book of Common Worship*, a rich resource that I have begun to explore with appreciation.

Two years ago, Stated Clerk J. Herbert Nelson, Jr launched a new initiative - Hands and Feet - to work with local churches in the city hosting the GA to tackle some of the problems pressing their communities. In St. Louis one of the main foci was raising awareness of the problems of black incarceration for minor offenses (even traffic violations) when the person is unable to pay even \$50 bail. Obviously, the consequences are devastating to the individual, family and community and include loss of jobs, loss of housing, and family disruption. In addition to the work done prior to the assembly, at GA we raised \$47,000 for bail and brought attention to the issue in various ways including a march to the City Justice Center (jail).

Worship was central to all our deliberations. It brought us together, refreshed us, and helped us to focus on what mattered. I especially appreciated the many voices included, among them pastors from Equatorial Guinea, Guatemala, France, Iran, El Salvador, South Sudan, Iraq, Korea, Puerto Rico, and the Arabic Presbyterian Church in Iowa, with primary leadership from churches in the Presbytery of Giddings-Lovejoy.

It was an honor and a privilege to represent the PSK at the 223rd General Assembly in St. Louis.

Conway Springs Commission

February 10, 2018 – Meeting of Presbytery of Southern Kansas – Moderator John Wilson appointed a Commission to work with the Presbyterian Church in Conway Springs. Members: Angela Madden, Moderator, Lora McGregor, Deb Schmidt, Mary Dusenbury, Sue Nispel, Steve McSpadden. Later Angela Madden resigned and Sue Nispel was asked to serve as Moderator.

March 6, 2018 – The Commission held its first meeting. Some of the history of the congregation at Conway Springs was reviewed. The congregation voted in December, 2017 to close. Deb Schmidt moderated that congregational meeting. The final worship service was held on January 31, 2018. Since that time, there has been no congregational activity, but 4 members still serve as Session members.

March 27, 2018 - Three members of the Commission went to Conway Springs and met with 3 of the session members. The discussion included ways to serve those people who are still on the rolls of the church, possible ways to celebrate the history of the congregation at Conway Springs and other issues. It was clear that there was no desire to have a closing celebration. The remaining Session members expressed a desire to leave some kind of "legacy", but there was no clear idea of what that might be. There was discussion of responsibilities that need to be completed including getting all church records (including Session records) ready to turn over to the Presbytery. There was discussion about the need to get the roof of the church repaired. An insurance claim had been filed in 2016 and the insurance company had sent payment for repair work, but the roof had not been repaired. When asked if they would get some bids for repair, they agreed to let the Presbytery trustees ask for bids. They also mentioned that at least one party had inquired about the future of the building.

April 6, 2018 – Three members of the Commission met at the Presbytery office. Steve joined by phone. Mary was not available. The three who had met with the Session at Conway brought the other members up to date and talked about ways to move forward.

April 24, 2018 - All five members of the Commission met at the Presbytery office in the afternoon. There was discussion about helping the Session members move forward in planning about a "Legacy" from the church. It was decided that we would not push them to hold any celebration and would not rush them to have any type of recognition at the May Presbytery meeting. Instead we will try to help them finish all their responsibilities and then be recognized at the Presbytery meeting in August.

April 24, 2018 - Sue Nispel went to Conway Springs and met with 3 of the Session members. It was agreed that they would be allotted \$25,000 from their current bank account to set up some sort of "legacy". There were several ideas discussed about where they would like to donate the funds. It was also made clear that they would be responsible to repair the roof of the building. Since they had already received insurance funds for the roof repair in July 2016, but not done the repairs, they are now asked to complete that responsibility. There was also discussion again about getting all church records brought up to date. A deadline of June 1 was given for both the repair of the roof and the completion of the church records. Not all of the records have been located so far, but hopefully most of them can be found. By their request, Ken Coryell has obtained bids for the roof repair.

May 15 – An Open House was held at the church building in Conway Springs to determine any interest in the building. Kirk Taylor and a member of his congregation in Argonia toured the Building. Members of the Conway Springs City Commission and Chamber were invited, but no one attended.

May 22 – A Contract has been signed for the repair of the roof. Insurance funds that had been received in 2016 are being used for the initial cost.

A meeting date of June 5 has been set to meet with both the Commission and the Session members. June 5 - The Commission and two Session members met in Conway Springs. A number of old church records were turned over to the Commission, but the current Session records have not been completed yet. The repair of the roof has been delayed due to weather. There have been decisions made about some of the legacy gifts. Alicia and Valerie will send the checks and send notes indicating that the gifts are from the Presbyterian Church. Cara has given a number of items to the Conway Springs Historical Society and the City Museum. Sue will contact the Sumner County Register of Deeds about the deed for the property.

Several notes and emails have been exchanged during the last few weeks.

July 24 — Deb Schmidt and Sue Nispel went to the Conway Springs nursing home before the meeting and served communion to one of the members of the congregation.

Lisa Bittle and Valerie Martin from the Session met with Deb Schmidt, Lara MacGregor, Mary Dusenbury and Sue Nispel from the Commission. The roof repair has been completed and the bill has been paid. The current Session records had been printed off and were turned over. The minutes from the congregational meeting of December 31, 2017 were signed by Deb Schmidt who moderated that meeting. The list and amounts of the "legacy" gifts were reported. A number of additional old records were found and delivered to the Presbytery office. The papers for the "dissolution" were signed and delivered to the Presbytery office. The Presbytery has been asked for 15 minutes on the August 14 agenda to celebrate the life and legacy of the Presbyterian Church of Conway Springs. These remaining members were assured that if they needed any pastoral care, they could call upon the Presbytery at any time. (This assurance came as a result of their concern that all of them have elderly relatives still living, who had been long time members of the congregation). The meeting was closed with prayer by Lara MacGregor.

At the close of the report at the Presbytery meeting, the Commission will ask to be dismissed and that the property be turned over to the Trustees of the Presbytery.

Sue Nispel, Moderator Conway Springs Commission
