**BYLAWS INFORMATION**

Article 2 of the Bylaws states:

The purpose of the Corporation is to provide and maintain a place for Christian education, fellowship, wholesome and supervised recreation for all ages without regard to race, color, creed or place of residence under such proper guidance, conditions, and environment as the Corporation may determine according to the principles of the Statement of Faith which is in accord with the Mennonite Faith.

The SMCA Statement of Faith:

**We believe in . . .**

- The Holy Scriptures as originally given by God, divinely inspired, infallible, entirely trustworthy and the supreme authority in all matters of faith and conduct;
- The Triune God - Father, Son and Holy Spirit;
- The deity of the Lord Jesus Christ, His substitutionary atonement for sin, His bodily resurrection and His personal, visible return to earth to reign in righteousness and glory;
- The Person of the Holy Spirit and His work of conviction, regeneration, and sanctification, who indwells every believer equipping them with gifts for service and witness;
- The necessity of new birth, in salvation by faith in Jesus Christ alone and the importance of a life fully committed to the will of God in Christ; and
- The church as the one universal body of Christ who is the Head, called to be God's redeemed people, living peaceably in the world but not of it.

Article IV, Section 1. B of the bylaws states:

Members shall be in good standing with a recognized Mennonite congregation or a congregation of another heritage that does not contradict the SMCA Statement of Faith. All such members are to be able to support the objectives and standards adopted by the Association.
