_____ I understand that all vacation notices and last day notices must be given to the day camp office in writing only and must be given ten (10) calendar days in advance—NO EXCEPTIONS.

_____ I understand that if I register my child(ren) for **All Stars Day Camp (summer)**, I am responsible for paying at least eight (8) weeks of camp unless a ten (10) calendar day notice is given.

_____ I understand that if I register my child(ren) for the drop-in program, I will be charged by the day regardless if I come the entire week. I also understand that at anytime if **All Stars Day Camp** is at capacity, my child may not attend for the day.

_____ I understand that I must pick up my child by 6 PM (**All Stars** clock time). I will be charged a fee of \$5 per minute after this time.

_____ I, the undersigned father, mother, or legal guardian of the above named child hereby authorize his/her attendance at, and participation in the functions, as well as travel to, from, and during such functions that are planned and/or sponsored by **All Stars Day Camp** of *Stoney Creek FWB Church*.

_____ In the event of any emergency where medical treatment is required, I give my permission to the **All Stars Day Camp** staff, representative, or sponsor to obtain the services of a licensed physician. **All Stars Day Camp** will notify me immediately concerning any such emergency.

_____ I release my child to the care and supervision of **All Stars Day Camp** given the information stated above as true and accurate. I will not hold the stated church, *Stoney Creek Free Will Baptist Church*, **All Stars Day Camp**, or any of its various ministries or workers responsible for any accident or injury which my child may experience.

_____ I understand that these activities may include field-trips, hiking, outside sports and games, swimming, and any other activities similar to and customarily associated with a day camp. I hereby certify that the aforementioned child is physically fit and adequately trained to engage in these activities.

Stoney Creek Free Will Baptist Church desires to provide an outreach ministry to youth within the Church and throughout the local community known as **All Stars Day Camp**. In order to promote the ministry goals, to maintain the structure of the program, and to provide for the safety and well being of the child and all participants and staff, it is necessary and appropriate to enter into an agreement regarding enrollment in **All Stars Day Camp**.

The child and parent(s)/guardian(s) and *Stoney Creek Free Will Baptist Church* agree:

1. *Stoney Creek FWB Church* will provide **All Stars Day Camp** ministry and related activities to the child as part of its outreach ministry consistent with church beliefs and doctrines.
2. The parent(s)/guardian(s) will timely pay all camp tuition and fees consistent with the selected payment plan. Any payment more than two weeks past due may result in the camper being expelled from All Stars Day Camp. The parent(s)/guardian(s) agree to pay all late fees and fees incurred for each charge.
3. The child shall obey all rules, regulations and procedures of **All Stars Day Camp**. The parent(s)/guardian(s) shall pay for any damage to church property caused by the child's failure to follow rules.
4. *Stoney Creek FWB Church* reserves the right and discretion to exclude or remove any child from **All Stars Day Camp**, temporarily or permanently, for any reason, including violation of rules, disruption of camp activities, and nonpayment of tuition. If a child is excluded or removed, any unused portion of tuition will be refunded.
5. The child and parent(s)/guardian(s) shall execute a Consent and Certification provided by *Stoney Creek FWB Church* authorizing day trips and any necessary emergency medical care and treatment for the child. Parent(s)/guardian(s) agree not to hold *Stoney Creek FWB Church* or its staff responsible for any accident or injury arising from day camp activities, including day trips, which are provided with reasonable care.
