- Secretary's Report Minutes

- Education and Youth Phil Baden
 - o Did not meet, nothing to report

Youth Report – Gretchen Michaels

- Working on NYG Prep, raised around \$4000 at Auction/Chili cook-off, roughly \$1600 shy of total needed
 - Bil suggested putting funds in the General Youth fund if more money is raised than needed for NYG
- Inreach/Outreach Jill Long
 - o Electronically submitted.
 - Discussing potential signs.
- Property/Cemetery/Interior Design Lisa Michaels
 - o Did not meet
 - Last month they discussed using Hog Roast money for fencing (Lisa to discuss with property)
 - O Jill mentioned Property needs to check out area around pulpit for touch-up
- Technology Ryan Rackley
 - o February and March minutes electronically submitted.
 - Guest wireless isn't working. Server continues to go down periodically. Private wireless is still working.
 - Proposal shared for Security plan
 - Provide automatic unlocking mechanism on outer glass door, doorbell to ring to Velda
 - Proposal is for 1 unit
 - Bil suggested purchasing camera on proposal and using the rest of the Hog Roast money for fencing
 - Discuss more next month to determine how the money will be divided (property vs Technology), money to stay where it is now-earmarked for property security
 - Temporary doorbell solution is in place, thanks to Mike Roberts
 - Discussed frequency of issues
- Worship and Music Gretchen Zody
 - o Met tonight, Pastor Jon shared gluten-free communion bread
- Personnel and Administration Tom Wilkinson
 - o Electronically submitted

- Discussion of secretary paid as salary or hourly, previously moved from Hourly to Salary. Bil reported that The Fair Labor Standards Act (FLSA) does not cover non-profit organizations except where the organization's activities are performed in connection with:
 - A hospital, nursing home or school that is covered by the FLSA; or commercial venture, such as a thrift store or gift ship, operated by the organization.
- Stewardship/Finance Peg Kennedy
 - o Electronically submitted
 - Have already received \$1000 donation toward a laptop for PJ, Stephen checking into models and prices (then we can determine how to pay for it)
 - A laptop would replace the desktop in his office (could be used elsewhere on site), would be frequently used in youth and multi-media events
 - Bil suggested it be considered church property, considered part of our technology equipment
 - Bil moved we approve purchasing a laptop and using a Des Tmp1 fund to pay for it and raise funds to replenish it later, Phil 2nd, motion passed. Amended motion not to exceed \$1500 – Tom moved, Phil 2nd, motion passed.

 - O Plans for future help PJ thinks we will need to look at this in the future (conversations to be part of our upcoming retreat). Budget and need to be considered. Possibility of utilizing Internship program (now a 2-year program).

 - VISA gift card to be presented by Tom at all 3 services
 - To be taken out of Misc. Expense (Under Other Expenses), 5.420.810
 - \$200 plus the fee Motion to approve giving \$200 gift card by Peg, Phil 2nd, motion carried.
