I fully support the leadership of KVM & ODM and do waive Tanner Street Church of God, Sikeston, MO and its employees and members of all liability. As a condition of participating in any trip during the year this form was completed. Participant shall (1) learn and consistently follow the rules of KVM & ODM and those set in place by Tanner Street Church/ Pastor Jessica,

and its associated activities, (2) obey all instructions of Tanner Street Church staff and volunteers, and (3) alert Tanner Street Church staff immediately of any dangers or hazards to the safety of any individual(s) participating in the KVM & ODM trips.

I give permission for Participant to participate in any trip during the year this form was completed, and all of its associated activities, including but not limited to those described above. I also authorize Tanner Street Church, its staff, and volunteers to provide or arrange for proper medical treatment to Participant. I understand that Tanner Street Church of God Staff and volunteers, will make every effort to contact Participant's parent and/or guardian (if Participant is under 18 years of age) in the event of a medical emergency. Nevertheless, I hereby give permission and authorize Tanner Street Church, and associated staff and volunteers, at any time they believe an emergency exists, to provide, facilitate, and consent to the provision of any first aid, doctor's care, hospitalization, surgery, transportation to medical facility, and/or any other form of medical care or treatment that Tanner Street Church Staff or volunteers, determines that Participant may need because of illness, injury, or other health problems that Participant may suffer while participating in any KVM & ODM trip or its associated activities. I agree to be financially responsible for any medical bills incurred as a result of medical treatment for Participant. I agree to release and hold harmless Tanner Street Church of God, and its employees, and volunteers it works in conjunction with, from any claims, liabilities, actions, demands, or losses for or from bodily injury, property damage, wrongful death, or otherwise, which may arise from provision or omission of any type of medical care or transportation to or from a treatment facility by those chosen by Tanner Street Church of God and associated staff or volunteers, to administer medical care for and/or transport Participant, and which may arise by any cause, including through the negligence or carelessness of Tanner Street Church of God and associated staff or volunteers. I understand that all reasonable safety precautions will be taken at all times by Tanner Street Church of God, and its representatives during the events and activities of all trips during the year this form was completed. I also give permission for Tanner Street Church and KVM & ODM to use any photographs or video taken of Participant while on any trip or during any associated activities during the year this form was completed. I understand that these photographs or videos, as well as Participants name may be used for such items including but not limited to: promotional materials, website material, publicity, and other uses and thus waive all rights to such materials which may include Participants likeness and/ or name.
