Canine Adoption Agreement

I, _____, do this _____ day of _____, 20____, enter into this adoption contract and acknowledge receipt from Teddy's Rescue the following dog:

I will take the dog to my veterinarian within 14 days of this contract for a check-up. Teddy's Rescue makes no representations or warranties regarding the health of this dog.

I will provide this dog with humane care and maintenance in accordance with all the current and future state, county, and local laws and ordinances where I reside.

I will provide the dog with necessary veterinary care upon sickness, disease, and injury. I will take the dog to the veterinarian once a year for an examination and routine vaccinations, tests, and care as needed.

I will provide a humane means of exercise. Being tied outside or chained is not allowed.

If, for any reason, I cannot keep this dog, I shall return it to Teddy's Rescue. The dog may not be sold, given away, or exchanged without the written consent of Teddy's Rescue.

All donations are non-refundable.

This dog will reside in my home as a household pet. This dog will not be used exclusively as a hunting or guard dog.

I will provide a collar and identification tag for the dog to wear at all times when allowed outdoors. I will keep this dog licensed according to state and county laws.

I agree, from the date of this contract, to release and indemnify Teddy's Rescue from any and all claims, known or unknown, now or hereafter arising in connection with this dog.

I consent to the examination of this dog by Teddy's Rescue at any time deemed necessary. Furthermore, Teddy's Rescue has the right to reclaim the dog at any time for failure to comply with the terms of this contract or for any misrepresentations of fact made on the adoption application or in this contract.

I agree to pay Teddy's Rescue for any and all expenses, including court costs and attorney fees accrued by enforcing the terms and provisions of this contract.

The adopter represents that he/she has never been subject to legal action for cruelty to or neglect of animals. The adopter further represents that he/she had never owned an animal which has been confiscated by any animal control or humane organization for violations of state or local animal control regulation or animal adoption agreements.

The adopter agrees to inform Teddy's Rescue if they ever intend to euthanize the animal for any reason other than in situations where a veterinarian has deemed it necessary to euthanize the dog due to irreversible illness or injury.

The adopter agrees to notify Teddy's Rescue within fourteen (14) days of a change of address or phone number for a period of one (1) year from the adoption date.
