Sandstone (Acker) has brought up that they are pow willing to take over the Fire Department Administration Duties. Department is fully funded by Special Millage and the Township's do NOT use general funds. Concerns that the Village will not part of the Board. Don't want to be the Police Department. We were told we would be treated good and covered for Police Power and now we are not covered. Further Discussion was done. Acker wanted to know if Village wanted to be "bought out"? Not an option in the Intergovernmental Agreement. Discussion. We need to heal. A good reason has never been presented as to why the Village should not do the books. Let's wait on making any decisions. Village has changed people on the Fire Board but the Townships have not in several years.
