Here are a few ordinances to keep in mind.

● Street numbers

As required in the Village and Jackson County all buildings shall be numbered. Street numbers shall be placed in an unobstructed location so as to be visible from the street and shall be of contrasting color to the building. Display the assigned address number on the structure in such a manner that it is visible from the road for emergency services. We ask that the numbers be no less than four inches in height.

We are asking residents to check to make sure that they are compliant with this ordinance by March 31st. After that date the Village will take further action to gain compliance of this ordinance.

● Garbage cans/bags Ordinance #51.22



Garbage/rubbish containers and bags must be stored on the owner's property. Not stored on the public right of way.

WATER ASSESSMENTS



Water Assessments are due on March 8, 2018. There is a 5% penalty on all past due bills per month. Be sure to get yours in on time.

Recreational Fires

Please be aware that a permit is required for any recreational burning in the Village. It is against Village Ordinance #204-06 and the NREPA Public Act 451 to burn leaves/pine needles/yard waste/storm damage waste in the Village or within 1400 ft. of the Village limits. Permits can be obtained at the Fire Department.
